Special Reports:

Chief Report on District Projects:

Chief of Support Koger gave a brief update on the Maintenance Facility. The permit has been received and mobilization will begin during 2021.

Chief of Support Koger gave a brief update on Station 1 and noted that there has been difficulty locating the original deed and legal description. He will continue to work with legal counsel to find the deed or have a new description created.

Chief Vincel gave a brief update on the Station 7 land appraisal and the landowner's disagreement with the appraisal.

Chief Vincel shared a video and gave a Presentation of the new Firefighters to the Board of Directors. Secretary Machuga made a motion to approve Resolutions adopting the 2021 budget, approving appropriation of funds, and authorizing tax levies to be certified by the District for collection in fiscal year 2021. Treasurer Anderson seconded the motion. The motion was passed unanimously by roll-call vote.





The District's third-party accountant Jim Pauley with Feis and Company gave a brief report on the 2021 budget. It was noted that no amendment to the 2020 budget was needed at this time.
