


Message from the Fire Chief



Today the South Adams County Fire Department responds to over 10,000 medical and fire calls per year. The diverse area we cover includes major highways, large industrial areas, commercial and residential properties, and the only refinery in the State of Colorado. SACFD is a special place with traditional roots, passion, innovation, and dedication that will always strive for what is best for our community and citizens that reside here and travel through. As an organization, we pride ourselves on what is written on our fire apparatus **“Serving our community with pride and excellence.”**

Since 2015 SACFD has hired over 76 Firefighters and 32 administrative personnel and counting. We have replaced dated fire apparatus, fire gear, SCBA, built a new indoor training and wellness facility, purchased a new Haz-Com unit, and purchased one of the only “Blocker Apparatus,” in the state. We strive on looking for innovative ways to provide our firefighters with the best while being good constituents with tax dollars. Some of the internal milestones SACFD has completed are SACFD a strategic plan that can be viewed on the website, CPSE accreditation modules on standards of cover and self-assessment modules (in hopes of being a fully accredited Fire Department at the beginning of 2024), and in 2023 also improved our ISO 2 score from an 80 to an 86 ½.




South Adams County Fire Department is a quasi-municipal district, organized and acting pursuant to the provisions of Colorado Revised Statutes Title 32: Special Districts.







EMS Division

The South Adams County Fire Department has implemented our Advanced Life Support (ALS) program as of January 1, 2023! The goal is to provide the highest quality services to our citizens with lots more to come! Currently, all our firefighters have (BLS) Basic Life Support Emergency Medical Technicians, however, we have added an additional service of ALS. Advanced Life Support or (ALS) is a set of life-saving skills and protocols that extend Paramedic capabilities beyond BLS. Some of the added services ALS provides are specializing in cardiac emergencies, strokes, and other lifesaving emergency conditions. SACFD now has a total of 13 Paramedics that will be added to the response 24/7.

An EMS Manager was hired in 2022 to oversee all aspects of emergency medical response in our district. SACFD also received grant funding to ensure that top-of-the-line EMS equipment would be carried on our rigs to help us provide you with the highest standard of care (such as LifePak15 Cardiac Monitor/Defibrillators, Glide scopes, Go video laryngoscopes, LCSU4 Suction units, etc.). This transition from the Basic Life Support (BLS) level to Advanced Life Support (ALS) will enhance prehospital care for the residents and visitors of Commerce City.






2022 Financials

Our budget funds a level of service that provides 24-hour-a-day, 7-day-a-week coverage from 6 strategically located fire stations staffed by full-time firefighters and supplemented by volunteer firefighters. Our fire department was rated by the Insurance Services Office (ISO) in November 2017 as a Class 2 which is one of the best ratings available. This enables us to return value to the taxpayers.



Training Division

South Adams County Fire Department also has several members that still maintain Colorado Division of Fire Prevention & Control (DFPC) certifications. DFPC requires 100% of Job Performance Requirements to be performed for each certification level every 3 years.

The Training Division aims to equip all levels of firefighters from the new recruit to the seasoned veteran with the knowledge, skills, and abilities necessary to handle the rigors of their job and to stay safe.

Division Training Chief Hunter Hackbarth is responsible for the day-to-day training and oversees the education, training, and record keeping annually.

Training Division

Significant Training Events:

- *Hosted and conducted the First “S.A.W” joint Fire Academy with South Adams County Fire Department, Arvada Fire Department, Westminster Fire Department, and Brighton Fire Department. Recruits participated in a 14-week (500+ hour) Recruit Fire Academy. Training delivery included: classroom, hands-on, and live fire. Topics included EMS, Hazardous Materials Awareness and Operations course, basic Firefighter I and II skills, and Driver Operator.*
- *Hosted and conducted a joint Lateral Fire Academy with Brighton Fire Rescue District. Conducted a Lateral Recruit Live Fire Training involving At-grade, Above-grade, and Below-grade live fire evolutions in order to assess (4) Lateral Recruits. The Lateral Recruits were evaluated on their skill-base level of live fire attack, VEIS operations, Forcible Entry, and Search Operations.*
- *Hosted Art of Reading Smoke Class. The training was taught by Rob Backer- First Due Intelligence LLC. Through PowerPoint, video, lecture, and discussion learned about the attributes of smoke, how fuels for structure fires have changed, and how to “read” smoke to determine where the seat of the fire is, where the fire is going, and how to recognize hostile fire events.*
- *Hosted joint live fire training with Brighton Fire Rescue District. Crews were given a hands-on live fire simulation at a multi-family residential structure with an above-grade fire. Officers will assume command, conduct a 360, and declare a strategy.*
- *Conducted a joint LPG live fire training with Adams County Fire Rescue District. Hands-on training with SACFD / ACFR line crews to review the use of handlines with fog nozzles to redirect burn LPG so that a safety valve can be manipulated to shut off the supply to the burning pipe.*
- *Participated in joint Wildland fire training at the Rocky Mountain Arsenal (RMA). Hands-on training on Brush Truck 26 with North Area Wildland Teams and the U.S. Fish & Wildlife Service.*
- *SACFD hosted the 1403 Live Fire Instructor Certification Class. This intensive three-day program explores the most recent NFPA 1403 standard and applies the principles of the standard to the student’s ability to instruct live fire training in a safe environment. Eight new SACFD live fire instructors completed the class.*
- *Participated in Skid Avoidance Defensive Driving Course. The training was taught by First Gear Driving School. The Training combines experienced coaching with hands-on experience behind the wheel of the SkidCar™ vehicle. The innovative technology of the SkidCar, can simulate hazardous driving conditions such as slippery roads and hydroplaning.*
- *SACFD sent 12 members to the FDTN Fire Combat Class in Indianapolis. Fire Combat is a unique training experience offered by the Fire Department Training Network. To provide the most realistic fireground training possible for firefighters, FDTN has created a scenario-based course designed to provide response-based experience for company officers, firefighters, and apparatus operators.*
- *Familiarization training with the new Scorpion Truck. Using safe and efficient practices set up the traffic blocker truck (Stinger 23), use all emergency features, and block or redirect traffic around accident scenes. This program was designed in cooperation with the Colorado Department of Transportation.*
- *Familiarization training with the Haz-Com vehicle. Using safe and efficient practices set up the 2022 Thor Motor Class A Toy Hauler (Haz Comm) for use as a HazMat response vehicle and a Command Post. Candidates will then show that they can successfully drive Haz Comm through the driving track at Fire Station 25 and through a street driving course.*


The Training Division consists of the Training Division Chief, two Training Captains, Training Officer-Quartermaster, Training Coordinator, and Accreditation.

New Indoor Training & Wellness Facility

Purchased in 2021, the training site is comprised of a 40,000 sq. ft. building on 4 acres of land. "The Pound" is a state-of-the-art indoor training space with administrative offices, a quartermaster area, multiple conference spaces, two clean classrooms, and one dirty classroom, all providing state-of-the-art audio-visual capabilities.

The indoor training bay is a space large enough to accommodate various fire apparatus with a water drainage system for indoor suppression drills.

The wellness side of the building includes our in-house physical therapist, a Work Comp Doctor's Office (once a week), in-house physical fitness assessments, a nutritionist, a professionally designed gym for training tactical athletes (firefighters), and a post-workout/training sauna. Our training center also includes an SCBA washer, bunker gear extractor/dryer, and duty uniform clothing washer/dryer to reduce the risk of contamination from work-related carcinogens.



It is important for our team to maintain good health on the job and our new gym supports the importance to have a good fitness level in order to maintain a high level of performance and to stay safe and injury-free.







Our History

February 9, 1942: The South Adams County Fire Department was formed as an all-volunteer fire department.

1942: The volunteers responded to 69 fire calls with 10 volunteers; in 2018 the department responded to almost 9,000 calls with over 45 career firefighters and 25 volunteers.

1952: South Adams County Fire District was formed with a 1/2 mill tax levy. In 2013, thanks to the citizens' faith in 5A, SACFD became a combination department of reserve firefighters and career staff.

1971: The South Adams County Fire Prevention Bureau was established with one fire inspector. Today the staff of seven uniformed and two civilian employees oversees 2,400 businesses, fire investigations, fire and emergency service impact fees, development and construction projects, and fire/life safety education

2014: South Adams County Fire Fighters Association was created to aid, and benefit injured or sick firefighters and their families, and support active and retired firefighters of SACFD.

2017: South Adams County Fire Department achieved an ISO Class 2 Fire Department. The Insurance Service Office (ISO) rating is a significant improvement from our previous rating (of nearly a Class 6/9)



2020: The department proudly announces the launch of our new company logo and badge. Our department has grown significantly, and we are always evolving, and this new refreshed look reflects the ongoing development of our department.

2021 - Expansion of Fleet Maintenance Shop: To enhance our abilities to keep up with our ever-growing fleet and be sure the Apparatus; Fire Engines, Trucks, Ambulances, and fleet vehicles are all in tip-top shape for a response.

2021- Strategic Plan (2021-2026): The strategic plan is a living management tool that provides short-term direction, builds a shared vision, documents goals, and objectives, and optimizes the use of resources.

2021: Purchased an existing 4-acre site with 40,000 sq. of building space in Commerce City to enhance our training division. The building provides state-of-the-art indoor training, space for personnel, quartermaster, Information Technology, an in-house Wellness Center with a physical therapist, and a doctor's office. Additionally, SCBA maintenance, reserve apparatus, and a workout facility.

Today: Our department responds to over 10,000 calls annually and has over 73 Firefighters and 28 Administrative staff. We protect approximately 76 sq. miles of residential, commercial, industrial, and open lands. Our plans and goal for 2023 include being an accredited department with (6) 24-hour staffed fire stations.
